Dear Sirs,

As you are aware Accredibase is carrying out a review of Euclid University, with a view to considering whether it should remain on Accredibase's database, given representations by Euclid that it has university status.

In order that we may complete our review please provide copies of the following:-

1. The 2008 University Charter referred to in the International Association of Universities' Handbook;
2. The 2008 approval of the Eritrean Ministry of Education/European Commission referred to in the IAU Handbook;
3. The authorisation to confer degrees accredited by the Ministry of Education referred to in Monsieur Denamsekete's letter to the IAU dated 21 April 2011; and
4. The University Charter and Mandate referred to in the letter from the Union of Comoros to the Embassy of the United States of America dated 6 May 2011.

Please also answer the following questions:-

- (A) Which country or countries has/have chartered or licensed Euclid to grant degrees;
- (B) For each country, please provide evidence of the relevant Charter or Licence, including a copy of same;
- (C) For each country, please provide evidence of that country's listing of Euclid with UNESCO as a chartered degree giver;
- (D) If the answer to (A) is "none", please explain how Euclid has gained degree granting status and provide appropriate documentation;
- (E) If the answer to (A) is "none", please explain what is the oversight body responsible for the granting of degrees by Euclid. Please provide appropriate documentation;
- (F) If Euclid claims to be a degree granter under a multi-national agreement, please (a) state which nations are parties to this agreement; (b) provide a copy of the agreement and (c) provide evidence of a Charter or equivalent formal authorisation to issue degrees in the same form as is used for other universities in at least one of those nations;
- (G) Please provide evidence that the multi-national agreement has the legal effect of establishing a degree granting entity with powers and rights equivalent to those of that nation's other chartered degree-granters under the laws of at least one of the nations that signed it; and
