## Ref: EUCLID registration in UK NARIC database and ERIC/NARIC

Your Excellency, Dear Ambassador Lyall Grant:

We have the honor to refer to the attached letter from the United Nations Secretariat (Office of Human Resources Management) dated 10 December 2010, as well as to the intergovernmental convention registered in the United Treaty Series as UNTS I-49006/49007.

Having been informed that the UK government agency "UK NARIC" does not currently include EUCLID (Pôle Universitaire Euclide / Euclid University) in its list of recognized institutions which is a requirement for graduates to pursue further studies in the United Kingdom or with British universities through distance learning, we would be grateful if you could forward this letter and documents to UK NARIC (Jochen Pichler, Head of NARIC Services) to ensure prompt processing of this formal update and request.

Ambassador Doubane, as former Minister of the Education, is well aware that these procedures are important and that the special status of intergovernmental universities, discussed in the correspondence with the UN Secretariat, requires such diplomatic exchanges to ensure proper dissemination of authoritative information. In addition, EUCLID is a newer South-South institution (formalized between 2008 and 2011) which also explains the necessity of this procedure.
