Comoros and the Central African Republic are among EUCLID's Participating States, EUCLID being an intergovernmental international organization with a university charter, headquartered in the Central African Republic. The constitutive text is now published in the United Nations Treaty Series (10/2011) under reference I-49006/49007. We are also attaching for information a recent Note Verbale issued by Office of Prime Minister Touadéra.


In view of the current enrollment and near graduation of several government-sponsored students serving in the United States (including Nelly Gicho-Niyonzima, Burundi (wife of the Permanent Representative); Omari Williams, St Vincent (Deputy Chief of Mission in Washington); Elizabeth Foray, Sierra Leone (Information Attaché in Washington), we would be grateful if your Permanent Mission could transmit this letter and information to your UNESCO Commission and Department of International Organization Affairs at the Department of State so that it may be on file for US-based evaluation agencies that EUCLID (Pôle Universitaire Euclide / Euclid University) is duly chartered to confer degrees by its Participating States and

enjoys full academic accreditation according to its constitutive mandate under international law (Article I).



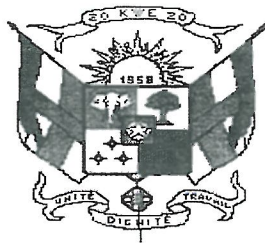

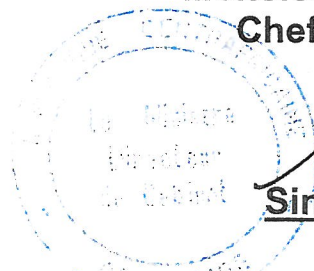
