

NOTE VERBALE regarding Article 102 filing of EUCLID instruments

The Government of Saint Vincent and the Grenadines is honoured to present its compliments to the EUCLID Secretariat General and to the Permanent Mission of Eritrea to the United Nations, and hereby confirms that there is no objection to the deposit of the EUCLID instruments by either EUCLID of the Permanent Mission of Eritrea for registration under Article 102 of "OPEN MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE PARTICIPATING EUCLID PARTIES REGARDING THEIR PARTICIPATION IN THE EDUCATIONAL FRAMEWORK DEFINED HEREIN" and "UPDATED FRAMEWORK AGREEMENT REGARDING THE PARTIES' PARTICIPATION IN EUCLID AS CONSTITUED AND DEFINED HEREIN" which are both governed by international law and eligible for registration, as in also indicated in Article V of the Framc Agreement:

"This framework agreement can be modified by mutual agreement of the Parties, the EUCLID Secretary General acting as depositary for Article 102 registration with the UN Secretariat General."

The Government of Saint Vincent and the Grenadines avails itself of this opportunity to renew to the EUCLID Secretariat General and to the Permanent Mission of Eritrea to the United Nations the assurances of its highest consideration
