Optional Protocol for EUCLID MOU Registration and Publication

Wishing to ensure the registration and publication of the 'EUCLID MOU' which is an international agreement entitled "OPEN MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE PARTICIPATING EUCLID PARTIES REGARDING THEIR PARTICIPATION IN THE EDUCATIONAL TRANSPORT DEPINED HEREIN." and initially approved in 2008 by the governments of (1) Saint Vincent and the Grenadines (2) Sierra Leone (3) Uganda and (4) Eritrea; the Signatory or Signatories have approved this additional optional Protocol and agreed as follows:

Article 1

The EUCLID MOU, (along the Statutes referenced in Article III of the MOU), is to be immediately registered and published in accordance with Article 102 of the UN Charter.

Article II

The EUCLID WOO, being the instrument used to organize the EUCLID educational framework, is confirmed to have established the non-profit status, international legal personality and mandate of EUCLID (Euclid University), as well as eligibility for the euclid int domain.

The present Protocol enters into force as a statement of clarification and request for publication upon initial signature and as a Protocol upon second signature.
