I first joined the Legal Office in September 1995 and worked there until 1 July 1998. During that time I was responsible for international economic law matters including negotiating

trade treaties and investment protection treaties. I was also responsible for liaison with Attorney-General's Department on international criminal law matters.

I returned to the Legal Office in March 2001 (when it was known as the Legal Branch) and then worked in International Law Section on international public and social law treaties and other instruments related to education, employment, family law, foreign aid, health and social security.

From 1 July 2003 until 27 August 2010 I worked in the Treaties Secretariat. (Albeit, technically, the Treaties Secretariat was part of International Law Section until 31 July 2006.) In Treaties Secretariat my responsibilities centered on general treaty law advice, legal projects and programs (such as developing the treaty database and reforming the treaty making system), formal liaison with the Joint Standing Committee on Treaties and advising on international instruments concerning foreign aid.

East Asia Branch (1998-2001).

Responsible for trade policy with Japan and trade and foreign policy with Hong Kong and Macau.

National Trade Strategy and Business Affairs Branch (1993-1995). Responsible for producing 1994 National Trade and Investment Development Guide, DFAT's management of 'Team Australia' and elements of the program for the 'National Trade and Investment Outlook Conference '94'.

Trade Competitiveness Branch (1992-1993). Responsible for DFAT's commodities policies.

GATT Branch (1990-1992). Responsible for multilateral trade policy and legal advice on international economic law.
